

<u>Curriculum Vitae</u> for Edward J. Priz, CPCU, APA

Edward J. Priz is a consultant, author, and expert witness on the subject of Workers Compensation insurance premiums, audits, classifications, experience modifiers, agent/broker professional standards and duties, and related issues.

He began his insurance career in 1976, starting as an insurance producer. In 1982 he also began consulting on Workers Compensation insurance issues, and in 1987 established his own consulting firm to specialize in this field, as Advanced Insurance Management.

Clients of this consulting practice have included manufacturers, contractors, utilities, transportation companies, staffing companies, a federal government agency, a chamber of commerce, and insurance companies and insurance agencies. Some well known clients have included Caterpillar, Inc., Federal-Mogul Corporation, Walsh Construction, Bridgestone/Firestone Tire, and the San Francisco 49ers.

Mr. Priz has also served as a consultant to insurers Lloyds of London, Zurich American Insurance, Zenith Insurance, Liberty Mutual Insurance, Dakota Truck Underwriters, Diamond Insurance Company, FCCI Insurance, and Great American Insurance on issues involving Workers Compensation insurance coverage and premium computation.
